**This workshop focuses on Evidence-based treatment (EBT) protocols described in recent aphasic treatment literature. West and Kelly present case studies to demonstrate how such protocols can be applied to aphasic clients of varying syndromes and severity. Outcome data from clients currently receiving treatment in the Lehman College Speech & Hearing Center will be presented. Participants will learn to select stimuli from a variety of sources and use them to develop computerized EBT protocols that are interesting and motivating for adults with aphasia. In addition, critical issues relating to providing services for chronic aphasia will be discussed.**

She is an ASHA Fellow.

Nadine Kelly is a lecturer in the Department of Speech-Language-Hearing Sciences at Lehman College, CUNY. She has treated patients with aphasia in acute care, sub-acute settings, skilled nursing facilities and in home care in the New York City area.
