To enter: all students currently enrolled in graduate programs who read papers at this year's conference and have not yet received their Ph.D. are eligible to submit their paper for consideration for the prize. Papers should be submitted substantially as read at the meeting in content and length (with only minor corrections permitted) and include footnotes or endnotes. Papers must be submitted electronically to the MACBS president, Andrew August (axa24@psu.edu) no later than two weeks after the end of the conference. A prize committee appointed by the officers of the MACBS will judge the papers and award the annual prize.
