POLICY

Graduate Courses for Undergraduate Credit

***In Short:** Manner in which an undergraduate student may utilize graduate coursework.*

Seniors may take graduate courses for undergraduate credit under the same tuition conditions as those of their undergraduate courses, provided that they have a (3.0) cumulative index and a (3.0) index in the area in which they wish to take the course. Courses may not count towards Pathways requirements or the residency requirement for the major/minor. Courses will be counted towards the calculation of Dean's List, Presidential Scholars, and departmental honors. Students must secure a recommendation and authorization from both the academic undergraduate and graduate advisors.

Full-time undergraduate students who receive permission to take graduate courses will be charged the undergraduate tuition rate for graduate courses which are applicable to the student's undergraduate degree, (within 120 credits required for graduation). If the student is part-time, the graduate rate will be charged for graduate courses and the undergraduate rate for undergraduate courses.

RELATED POLICY

Transfer of Credit

***In Short:** Manner in which a degree-seeking graduate student may transfer graduate coursework completed during their undergraduate career.*

Students who wish to have graduate credits transferred should apply during their first semester in attendance as a matriculated graduate student at Lehman. The Application for Transfer of Graduate Credit form is available in the Office of Graduate Studies and online. All credits to be applied toward a Lehman College master's degree are subject to the approval of the Graduate Program Advisor and the Office of Graduate Studies. Transfer credits must conform to the regulations for the program and the curriculum in which the student is matriculated.
